4. What is expected of an Educator.

As an Official Educator, you will run your own training business, but be associated with Sunshine Training, Sunshine Academy Start-Ups and Sunshine Online Courses and other businesses relating to the Sunshine Group, and therefore be entitled to use our name and logo to promote your business. However, there are some standards you will need to abide by in order to stay affiliated with our brand, which includes the following.

Training standards.

A key selling point and advantage to using an Official Sunshine Educator, is that they only conduct training on a one-to-one, or in small groups, where students get personal attention and support. Practical training needs to follow our approved lesson plan. Only in this way can we be assured every student receives the same high standards, this is our standardisation process. With the launch of our new system, all Lesson Plans will be online, as well as all recording and reporting. The issuing of certificates will depend upon you following procedures. We will be launching the new system in a phased approach. Phase one is launched and we await phase two. You can produce a certificate through the new system, However, there are procedures to follow in completing this form, so we know that high standards are being maintained. We will require pictures of training as well, these to be sent via email. You must be satisfied the student is competent in the subject before requesting a certificate. If not, you may request the student submits practical assessments.

We do not believe in issuing certificates just because a student attended a course. If they are not competent, they are not entitled to a certificate. You could devalue the certificate for all those who worked hard at achieving their certification if we don't adhere to standards. In requesting a certificate, you are making a declaration that the student is competent and has followed the lesson plan as set out by the training course.

What is expected of an Official Educator

Educator requirements.

- You may only teach the subjects you are qualified in and have completed at least
 - Three year's experience in that subject.
 - Have valid teacher insurance.
- Have, and maintain a CPD log, which we may view.
 - Sufficient knowledge to teach students.
 - Provide exceptional customer service.

Running your own business.

As you are running your own independent business, we do not stipulate any rules you must follow. It's not our place to do so. However, your own common sense will tell you that you need to use the highest standard in customer care and service to remain competitive. If you want help running your business, we can assist you through many and varied services. You pay for these services as and when you need them. Some of our **Support Services** are listed in this document. Obviously, we want you to be successful and will help as much as we can. Your success is our success.
